# About E-gov4youth



*E-gov4youth partners YYOUTH and UBBSLA met in Potenza, Italy for the Kickoff meeting in April 2024.*

## Project outputs

- **Skills Gaps Research Report:** An in-depth study to identify skills gaps in the context of E-GOV;
- **Training Programme:** aimed at youngsters not in education, employment or training (NEETs) aged 18– 29 years old.
- **Massive Open Online Course (MOOC):** which will be based on the 6 modules of the already tested and validated course. The MOOC will make the training free of charge, accessible by anyone and at any time.
- **Dialogue Platform:** useful for decision making between young people and PA, co-developed by young people and institutions
- **E-GOV Permanent Network Mechanism:** which will be exploited for bottom-up co-design of youth-driven local development policies

## Target groups:

- Young people 24-29 years old out of education, training and the labor market (NEET)
- Youth organizations
- Local institutions & Public authorities

- The E-gov4 project, co-funded by the European Union, spans 30 months from March 2024 to August 2026. It will be implemented by six organizations based in Italy, Greece, Norway, Estonia, Bulgaria, and Cyprus.
- EGOV4YOUTH tackles the challenges of expediting the digitalization of public services and boosting civic engagement among young people. The project focuses on equipping youth with E-GOV skills and tools to promote local development, fostering cooperation between young individuals and public bodies in decision-making processes.
- EGOV4YOUTH provides an E-GOV training program for young not in education, employment or training (NEETs), highlighting E-GOV technologies, digital civic engagement, open data and transparency, security and ethics, and resources for local growth. Furthermore, the initiative encourages collaboration between young individuals and public entities in creating E-GOV resources to enhance youth participation in decision-making.
- It also establishes enduring partnerships among public bodies, youth organizations, research institutions, and the private sector.
